Be it ordained by the Sangguniang Panlungsod of Iligan in its session assembled, that:

SECTION 1. - There is **AUTHORIZED**, as the same is hereby **AUTHORIZED** for the temporary closure of portions of the following streets for the various activities of the *2022 Diyandi Festival sa Iligan*, namely:

September 28, 2022	5:00 A.M. – 6:00 A.M.	Port Area, Tomas Cabili Avenue
October 7, 2022	6:00 P.M onwards	Tomas Cabili Avenue

SECTION 2. – The Iligan City Police Office and the Iligan City Traffic Division are hereby required to provide traffic officers to monitor, direct and control traffic in order to avoid unnecessary traffic congestion thereat.

SECTION 3. Effectivity - This Ordinance shall take effect upon its approval.
