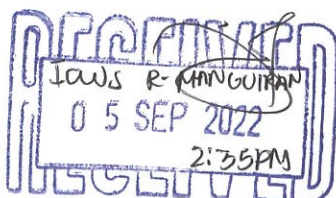

CITY ORDINANCE NO. 22 – 7200

AN ORDINANCE AUTHORIZING FOR THE TEMPORARY CLOSURE OF PORTION OF MARIANO BADELLES STREET (FROM THE CORNER OF SAN MIGUEL STREET UP TO THE APPROACH OF TAMBACAN BRIDGE), BARANGAY POBLACION, ILIGAN CITY AND THE UNNAMED ROAD IN BETWEEN PUROKS 1 AND 2 OF TAMBACAN (APPROACHING TAMBACAN BRIDGE) FROM 7:00 O’CLOCK IN THE EVENING OF AUGUST 24, 2022 TO 8:00 O’CLOCK IN THE MORNING OF AUGUST 25, 2022, DUE TO THE DISMANTLING OF THE OLD DILAPIDATED PIPES AND INSTALLATION OF 450MM Ø (18INCH) SPIRAL WELDED STEEL PIPES BY THE ILIGAN CITY WATERWORKS SYSTEM (ICWS)

Be it ordained by the Sangguniang Panlungsod of Iligan City in its session assembled, that:

SECTION 1. - There is **AUTHORIZED**, as the same is hereby **AUTHORIZED** for the temporary road closure of Tambacan Bridge. The roads to be affected are the following:

Portion of Mariano Badelles Street (Approaching Tambacan Bridge) and the unnamed road in between Purok 1 and Purok 2 of Barangay Tambacan.

SECTION 2. TIME AND DATE OF CLOSURE

August 24, 2022 at 7:00 o'clock in the evening to August 25, 2022 at 8:00 o'clock in the morning.

SECTION 3. Effectivity – this Ordinance shall take effect upon its approval.
