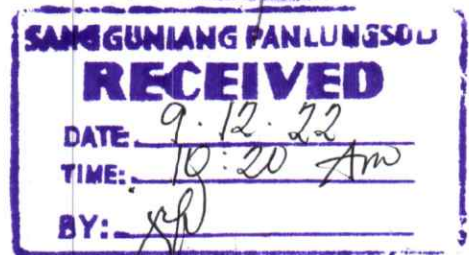
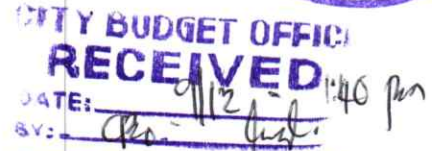

WHEREAS, presented to the body for deliberation was a letter dated September 1, 2022, from City Mayor Frederick W. Siao, requesting for the passage of an Ordinance granting P70,000 Economic Welfare Assistance (EWA) to all qualified officials and employees of the City Government;

WHEREAS, as to where the funds shall be sourced for the payment of EWA, City Mayor Frederick W. Siao, also requested that he be authorized to transfer the "Salaries and Premiums Savings" covering the period from January 1-July 2022 to "Other Personnel Benefits" under the "City Mayor's Office-Retirement And Other Personnel Benefits";

WHEREAS, for years, the Iligan City Government has been granting Economic Welfare Assistance (EWA) to all qualified officials and employees of the City Government of Iligan and past releases of EWA showed these were usually done every September before fiesta and December of the year;

CITY ORDINANCE NO. AO 22-7209-35

AN ORDINANCE AUTHORIZING CITY MAYOR FREDERICK W. SIAO TO TRANSFER THE SALARIES AND PREMIUMS SAVINGS COVERING THE PERIOD FROM JANUARY 1-JULY 2022 TO "OTHER PERSONNEL BENEFITS" UNDER THE "CITY MAYOR'S OFFICE-RETIREMENT AND OTHER PERSONNEL BENEFITS" AS SOURCE OF FUNDS FOR THE GRANT OF ECONOMIC WELFARE ASSISTANCE (EWA) IN THE AMOUNT OF SEVENTY THOUSAND PESOS (P70,000) AND AUTHORIZING FURTHER CITY MAYOR FREDERICK W. SIAO, TO PARTIALLY RELEASE THE AMOUNT OF TWENTY THOUSAND PESOS (P20,000) FROM THE EWA, BEFORE SEPTEMBER 29, 2022

Be it ordained by the Sangguniang Panlungsod of Iligan in session assembled, that:

SECTION 1. There is **AUTHORIZED** as the same is hereby **AUTHORIZED**, City Mayor Frederick W. Siao to transfer the "Salaries and Premiums Savings" covering the period from January 1-July 2022 to "Other Personnel Benefits" under the "City Mayor's Office-Retirement And Other Personnel Benefits" as source of funds for the grant of Economic Welfare Assistance (EWA) in the amount of Seventy Thousand Pesos (P70,000).

SECTION 2. City Mayor Frederick W. Siao is **AUTHORIZED** as he is hereby **AUTHORIZED**, to partially release the amount of Twenty Thousand Pesos (P20,000.00) to every employees and officials of the City Government entitled and qualified to receive the EWA, before September 29, 2022.

SECTION 3. Repealing Clause - All previous ordinances, executive orders, rules, and regulations or parts thereof which are inconsistent with this ordinance are hereby repealed and/or modified accordingly.

SECTION 4. Separability Clause - If any part or provisions of this Ordinance be held unconstitutional or invalid, other parts or provisions hereof, which are not affected thereby shall continue in full force and effect.

SECTION 5. Effectivity - This Ordinance shall take effect immediately upon approval.
